

## **End of Year Report for 2014 Livingston County Sheriff's Office**

The LCSO is permitted by County Commission to have 7 full time Road Deputies and the Sheriff to cover all law enforcement needs in Livingston County. This includes all criminal investigations, calls for service, court security and bailiff duties, prisoner needs/transport/housing, civil process service, Court orders, sex offender registrations, concealed carry permits, exotic animal registrations and assist other agencies.

**Significant Cases for 2014 included:**

Rape Investigation where a former Chillicothe Police Officer was arrested, charged and convicted at Jury Trial.

Various Child Sex Offense investigations that have resulted in charge(s) and convictions.

Burglary/Thefts/Stolen Vehicle investigation where suspect fled through multiple counties on alleged crime spree. Suspect apprehended after lengthy chase in Macon County and Missouri State Troopers allegedly shot at by suspect.

Residential burglary case where 2 suspects arrested and multiple stolen firearms recovered for property owner. Both men incarcerated.
